**Inspector Comments:** A follow up inspection was conducted on this date by the San Bernardino County Division of Environmental Health to verify compliance in regards to active rodent infestation closure from complaint inspection.

Facility was observed closed upon arrival.

Observed numerous rodent droppings in the back storage area in the following locations:

- Between excess metal shelving.
- Between pressurized cylinder tanks.
- Underneath employee break table.
- Behind various pallets closest to wall area.
- One dropping on a box of "kids story books".

Also observed a rodent dropping on shelving out near bottled drinks.

Manager stated that pest control came the day prior to inspection to service facility for infestation. Manager stated that no receipt of services was left.

Due to the numerous rodent droppings in facility an active infestation is still observed. Permit is to remain suspended.

Clean and sanitize the affected areas and ensure to eliminate all evidence of rodents.

Advised manager to provide a copy of receipt of pest control services conducted on facility.

NOTE: Facility began clean up of rodent droppings discovered during follow up inspection.

**Description:** Reinspection conducted at this time to determine compliance from prior inspection.
