Inspector Comments: This facility was closed on 4-13-16 due to a roach infestation. Roaches were still observed on 4-18-16 during a re-inspection. Therefore, the facility was still ordered closed.

A billable inspection is conducted today. At the time of inspection, no roaches or roach activities observed. Observed receipts of services from Southern Cali Pest Control dated 4-14-16 and 4-18-16. Also, observed receipts of services from Mercado & Son Pest Control dated 4-20-16 and 4-21-16. Therefore, the permit that was suspended on 4-13-16 is now reinstated. The facility can now reopen for business.

Note: The B grade that was earned on 4-13-16 is now posted to replace the closed sign. Continue to work on all other violations noted on the inspection report of 4-13-16. Left a copy of re-score inspection request form.
