	Complied on 3/25/2015 Violation Reference - HSC - 114047, 114049, 114051	Observed raw meat stored above onions in walk-in refrigerator in meat market.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

	Not In Compliance Violation Reference - HSC - 114115 (c)	Observed excessive dust build up in walk-in refrigerators as well as walk-in freezers throughout the facility. Observed excessive food build up under cold holding units in meat market.

Violation Description: All nonfood contact surfaces of utensils and equipment shall be clean. (114115 (c))

	Not In Compliance Violation Reference - HSC - 114067 (j), 114123	Observed deliver door open and air curtain was not on. Corrective action: Operator turned air curtain on.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)
