**Inspector Comments:** Our department received a foodborne illness complaint allegedly resulted from eating of beef burrito. The complainant added that the meat was cold in the center of the food, that the sauce has a foul odor, and that the cook did not use gloves to handle open food.

At the time of inspection, observed several potentially hazardous foods inside the cold prep refrigerator in the kitchen at 54 degrees F.

Maintain cold potentially hazardous food at 41 degrees F or below at all times. See VC&D.

Immediately repair this cold prep refrigerator to maintain food temperature at 41 degrees F or below within 48 hours. Note: There will be a re-inspection on Friday, 5/17/19. Call (800) 442-2283 for questions.

Provide thermometer inside this prep refrigerator. No thermometer observed.

Observed salsa bar in the self-service area without sneeze guard or any form of overhead protection. Immediately remove this salsa bar in the self-service area until overhead protection is provided.

Note: Corrected on site.

Observed no test strips to check the concentration of sanitizer water. Provide sanitizer test strips.
