Observed the following potentially hazardous foods in the cold holding unit behind the cook's line to measure between 45-47 F:</p> <ul style="list-style-type: none"> - Container of raw shrimp - container of raw chicken - container of raw beef - container of liquid egg with yolk - container of raw fish - container of ground pork <p>2. Observed six (6) raw duck dry hanging in room temperature next to the walk-in cooler. Upon questioning, the cook explained that duck had been out for three (3) hours.</p> <p>Ensure all potentially hazardous foods (PHF) are maintained at 41 F or below for cold holding and 135 F or above for hot holding.</p> <p>Corrected on site: The manager was educated about the proper procedures for cold holding potentially hazardous foods and was instructed to place the foods in the refrigerator to cool to 41 F or below.</p> <p>NOTE: Upon questioning, the cook was not aware of correct cooking time for whole roast duck.</p> <p>Chinese-style barbecue duck, dry hung duck, and Peking duck. "Chinese-style roast duck" means duck which is prepared as follows:</p> <ol style="list-style-type: none"> (1) The abdominal cavity is cleaned. (2) The duck is marinated. (3) The cavity is closed prior to cooking. (4) The duck is roasted at a temperature of 350°F or more for at least 60 minutes. <p>If duck is not prepared as above, time as a public health control can be used, or dry duck inside of the walk-in cooler.</p>

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

47. SIGNS POSTED; LAST INSPECTION REPORT AVAILABLE

Upon questioning, the host explained that letter grade was posted at the front window by the door. From the outside, facility windows and doors are tinted so was unable to see letter grade. <u>Ensure letter grade is properly posed in an area that customers are able to easily see.</u> <u>NOTE: Letter grade was posted inside on the right side of the lobby area.</u>

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.

Overall Inspection Comments

On this date a "B" grade card was posted.

Do not relocate or remove the grade card. Do not cover up, obscure, deface, mar, or camouflage the grade card. Failure to comply will result in a charged inspection at an hourly rate of \$245.

For a B grade (score of 80 to 89) A re-score inspection may be requested by a food facility who receives a "B" grade after the completion of an official routine inspection. This request is optional on the part of the facility which may wish to try to improve their score or letter grade. The Health Official will complete the re-score inspection within ten (10) County business days of the food facility submitting a request for a re-score inspection. The inspection rate is \$245.00 per hour. A minimum of \$122.50 will be charged for the first 30 minutes of inspection time.

A Letter Grade Card shall remain valid until the Health Official completes the next routine inspection or re-score inspection of the food facility. A re-score inspection is a new, unscheduled, complete routine inspection that a) may be required by County Ordinance; or b) may be requested by the food facility.

Optional re-score form was provided at the time of this inspection.
