Inspector Comments: Observed employee come from customer area into food serving area and began to serve customer without first washing hands. Employee was also observed with acrylic nails.

Ensure that employees wash hands before handling or serving food when hands have been contaminated or when returning to food service after contacting any task outside food service area.

Ensure food service employees wear gloves when appropriate such as when they have acrylic nails or nail polish.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

Inspector Comments: Observed the following hot holding items out of temperature.

1. Orange chicken at 115F
2. Egg rolls at 115F
3. Broccoli beef at 117F

Ensure that hot holding food is kept at or above 135F.

Note: Portions of the foods were at and above 135F. Ensure to stir food frequently to ensure that the temperature is consistent throughout.

Corrected; Operator placed lids on the containers holding these foods.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

All utensils and equipment shall be approved, installed properly, and meet applicable standards. Inspector Comments: Observed utensils in bucket containing a small amount of unknown pink liquid at front serving line.

Observed a small plastic container inside of the dry rice container being used as a scoop.

Ensure that that utensils are stored in dry, clean containers.

Avoid using utensils without handles as food scoops.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)
