

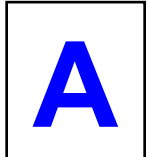

**Inspector Comments:**

(1) The following foods were observed out of temperature in walk-in refrigeration unit:

- Cooked steak at 92 F
- Raw steak at 49 F
- Raw pork at 45 F

Cook stated that all potentially hazardous foods mentioned above were stored in walk-in refrigerator over night.

Maintain all potentially hazardous foods in cold holding at 41F or below.

All food mentioned above was voluntarily condemned and destroyed. (see VC & D)

(2) The following foods were observed out of temperature in reach-in refrigeration unit:

- Tomatoes at 47.9 F
- potato tacos at 52 F
- Chorizo at 44 F
- Raw shelled eggs at 49 F
- Salsa at 58 F

Cook stated that all foods mentioned above were stored in reach-in refrigeration unit at approximately eight (8) in the morning.

Maintain all potentially hazardous foods in cold holding at 41F or below.

All food mentioned above was voluntarily condemned and destroyed. (see VC & D)

**Violation Description:** Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

(1) Observed reach-in refrigeration unit and walk-in refrigeration unit gaskets in disrepair.

Repair/replace gaskets.

(2) The kitchen reach-in refrigeration unit in the kitchen was observed to not be operable. Manager stated that reach-in refrigerator will no longer be used.

Repair or replace this refrigeration unit so that all potentially hazardous foods are held at or below 41 F at all times.

**Violation Description:** All utensils and equipment shall be fully operative and in good repair. (114175). All utensils and equipment shall be approved, installed properly, and meet applicable standards. (114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114177, 114180, 114182)

A copy of the last San Bernardino County Health Department inspection report was not available this date.

**Violation Description:** Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location. (114381(e)) Letter Grade Placecard shall be properly posted. SBCC 33.1406

The following potentially hazardous foods were voluntarily condemned and destroyed by the cook:

- Cooked steak ( 1 pound)
- Raw steak (14 pounds)
- Raw pork ( 7 pounds)
- Tomatoes (1 cup)
- potato tacos (18)
- Chorizo (1 cup)
- Raw shelled eggs (15)
- Salsa (25 little containers)

**Violation Description:** Operator has voluntarily consented to the condemnation and destruction of food as said material being unfit for human consumption or otherwise in violation of California Health and Safety Code, Division 104, Part 5, Chapter 1 through 8, the disposition of which is provided for by Chapter 8, Article 3, Section 111895.
