9. PROPER COOLING METHODS

Inspector Comments:

-Observed a tray of cooked egg whites cooled at room temperature, measured between 52°F - 125°F at front service area. Per operator, facility has always cooked eggs in microwave, then cooled eggs outside until temperature of eggs reach room temperature, and finally transferred to refrigerator for proper cold-holding. Ensure all potentially hazardous foods are cooled rapidly from 135°F to 70°F, within 2 hours, and then from 70°F to 41°F, within 4 hours. Cooling shall be done by one or more of the following methods: shallow containers, ice bath, or separating food into smaller portions and cooled in refrigerator.

Corrective action at time of inspection:

-Operator transferred tray of cooke egg whites into refrigerator for continued cooling and cold-holding.

NOTE:

-Egg whites were cooked recently, per operator.

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

(113947) Food facilities that prepare, handle or serve non-prepackaged potentially hazardous food, shall have an employee who has passed an approved food safety certification examination. (113947-113947.1)

Inspector Comments: Observed ice scoop in ice machine, with ice scoop handle touching ice. Ensure ice scoop is held with handle in upright position in ice machine OR keep ice scoop in separate container, outside of ice machine, after every use to prevent possible contamination of food products.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

39. THERMOMETERS PROVIDED AND ACCURATE

Inspector Comments: Observed a probe thermometer missing. Provide probe thermometer to properly measure internal temperatures of foods.

Violation Description: An accurate easily readable metal probe thermometer suitable for measuring temperature of food shall be available to the food handler. A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)
