- \* The owner, Anil Kumar, was interviewed by phone. He gave assurances that no further construction activity or food sales would occur until he obtains approval from Public Health.
- \* No food of any kind was observed in the store.
- \* Observed new equipment: Hand sinks: 2; Floor sinks: 2; Restrooms: 2; three compartment sink: 1; mop sink: 1; 1, 50 gal / 6000 watt water heater.
