On 9/11/19 the health permit for this facility was suspended due to a cockroach infestation. On this date, after a thorough reinspection of the entire kitchen facility, bathrooms and dining area, no live or dead cockroaches were noted; no vermin or evidence of vermin was noted.

A supervisory review will be scheduled to determine compliance.
