16K999 Complaint Inspection

Inspector Comments: Environmental Health received a complaint stating the restroom does not have running water, and the store is aware but not concerned.

Reference - HSC

Discussed nature of complaint with manager who is aware of the water not being functional.

Manager stated water has not been functioning since 6/2/22 due to small opening in horizontal seam of the exterior, secondary water tank, which caused water to escape. According to manager, seal was compromised by a person after hours while was closed.

According to manager, unsuccessful attempt to repair seam was made by using silicone, however, opening was still observed present. Manager stated a repair request has been made to properly weld seam to eliminate leak.

Due to exterior water tank in disrepair, facility does not have running water available (see hot and cold water violation).

Facility shall not offer prepackaged food or beverages due to lack of running water (see permit suspension comment).

Toilet facilities observed not functional due to no running water. Porta-potty and handwashing station observed stationed at rear door of facility for use. Toilet paper, soap and paper towels were observed supplied in dispensers.

Routine inspection conducted same day.

Complaint closed.

16C021 Hot and cold water available
