9. PROPER COOLING METHODS **MAJOR**

Inspector Comments: 1.) Observed four large plastic bins of cooked pasta and stacked on top of one another stored in the tall two door refrigeration unit in rear kitchen (downstairs) holding at an internal temperature of 58-60F. Upon investigating, person in charge stated that pasta was made approximately four hours ago and they were placed in the cooler for cooling.

2.) Observed three drawers underneath main cook line to have various pastas holding at 58F. Upon investigating, person in charge stated that this batch is the same as the one found in the tall refrigerator(see violation above). Proper cooling procedures had not been conducted.

Ensure to practice proper cooling in that containers are allowed adequate airflow during the cooling process.

Ensure potentially hazardous foods are cooled rapidly from 135°F to 70°F within two hours and then cooled from 70°F to 41°F or below for a total of six hours using approved cooling methods. Approved cooling methods include;

1. Placing the food in shallow, heat-conductive pans.
2. Separating the food into smaller or thinner portions.
3. Using rapid cooling equipment such as chill blasters.
4. Adding ice as an ingredient.
5. Using ice paddles.
6. Placing containers in an ice bath, stirring food frequently.
7. In accordance to an approved HACCP Plan.

When placing food in the refrigerator to cool, containers should be loosely covered or uncovered if protected from overhead contamination and to facilitate adequate heat transfer.

When cooling potentially hazardous food in refrigerator leave slightly open to allow heat transfer.

Corrected on site. Person in charge was informed and corrected the bins for proper cooling.

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

Ensure all employees understand the proper dishwashing method.

Corrected on site. Employee drained water and refilled with clean water measuring 100F.

Ice machine did not have an air gap at floor sink piping. Ensure there is an airgap between floor drain and piping of equipment at least twice the diameter of the inlet or more than one inch. All steam tables, ice machines and bins, food preparation sinks, ware washing sinks, display cases, walk-in refrigeration units, and other similar equipment that discharge liquid waste shall be drained by means of indirect waste pipes, and all wastes drained by them shall discharge through an airgap into a floor sink or other approved type of receptor. 2.) Observed small faucet lean at two compartment sink faucet. Tighten in good condition.

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose.
