Inspector Comments: Observed one (1) employee to have artificial nails working the food service and dispensing line without wearing gloves.

Ensure all employees working with food who maintain artificial nails are properly wearing and using single-use disposable gloves while working. Proper hand washing procedures must be still be maintained and hands must be washed any time gloves are removed or changed.

Employee was informed of proper glove use methods when maintaining artificial nails.

Corrected on site.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

Inspector Comments: Observed five (5) covered containers of raw meat stored directly on the floor beneath dry storage racks in walk-in refrigerator.

Ensure all food is stored a minimum of 6-inches off the floor on approved shelving.

Operator removed containers of raw meat and placed in an appropriate storage space off the floor.

Corrected on site.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

Inspector Comments: Observed the following non-food contact surfaces in need of cleaning:

- Exterior lids of multiple bulk food storage containers i.e flour, sugar, rice, with sticky residue build up
- Handles and buttons of rice cooker lids with sticky residue build up

Ensure all non-food contact surfaces are properly cleaned and maintained free of any residue or build up.

Violation Description: All nonfood contact surfaces of utensils and equipment shall be clean. (114115 (c))

40. WIPING CLOTHS: PROPERLY USED AND STORED

Inspector Comments: Observed multiple wet wiping cloths stored on counter tops throughout the kitchen facility.

Ensure all wet wiping cloths are stored fully submerged in sanitizing solution when not in use.

Operator placed all sanitizing cloths in containers of chlorine sanitizer. Chlorine measured above 100 PPM.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

Inspector Comments: Observed personal items including a cell phone stored on cold holding unit table at onset of inspection.

Ensure all personal items are stored away or in a designated and identifiable area away from and food or food contact surfaces.

Operator removed personal items.

Corrected on site.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

IMPORTANT: Risk Based Inspection Frequency

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code [Schedule of Fees](#). Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
