Inspector Comments: A permit investigation was conducted on this date to close this facility for failure to provide the necessary documentation and fees to obtain a valid health permit.

On the last routine inspection, conducted on 12/12/18, the facility was noted to have a different name ("The Fifth") than was noted on this report ("Kicks Sports Pub"). The owners indicated a change of ownership had taken place. A Transfer of Ownership form was given to the owners at that time, however, the form has not been completed and sent to the San Bernardino Environmental Health Department.

A re-inspection was conducted on 2/12/19 and the manager notified that the facility was operating under an invalid health permit due to failure to turn in a Transfer of Ownership form. The Transfer of Ownership form was again provided on this date.

The manager was notified to provide the completed application and the applicable fee to this department by 2/15/19 to avoid facility closure and/or other potential legal action.

As of this date, the Transfer of Ownership form and the applicable fees have not been received. The facility is hereby closed. A closure notice has been posted on the front door. The grade card has been removed.

Violation Description: If an imminent health hazard is found, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed. (114409, 114405)
