Inspector Comments: Observed greater than 8 live, adult cockroaches on clean dishes and coffee cambros stored above ware washing area. Observed two live cockroaches on floor of cook's line and one live cockroach on floor next to delivery door.

Not In Compliance

Violation Reference - HSC - 114259.1, 114259.4, 11425

Ensure cockroach infestation is eliminated within 24 hours and facility is kept free of cockroaches to prevent contamination to food, equipment, packaging, or utensils.  
Ensure facility constructed, equipped, maintained, and operated as to prevent the entrance and harborage of cockroaches..

**Violation Description:** Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)
