One dead adult cockroach was observed on the floor by the water heater and another dead adult cockroach was observed below the three compartment sink. The operator removed the dead cockroaches. The operator produced recent professional exterminator receipts showing pest control service conducted at this facility within the last twenty four hours and stated another pest control service is scheduled on 6/23/2018. This food facility was observed to be in a clean and sanitary condition. The health permit for this facility was re-instated this date. The notice of closure sign was removed this date. Continue to maintain this facility in a clean and sanitary condition and free from vermin-including but not limited to cockroaches. | | | |
