

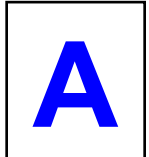

At time of inspection, no food was being actively prepared or cooked and no active adulteration was observed. Ensure to take appropriate measures to eliminate flies from the rear kitchen area. A food facility shall not operate when there is a vermin infestation that has resulted in the contamination of food-contact surfaces, food packaging, utensils, food equipment, or adulteration of food.

Observed many un-used equipment and items throughout the facility. Items that are not necessary to the operation, must be removed to prevent potential vermin harborage. 2. Observed two trees (one on the South side and one on the West side) on exterior of the building within 1 foot of building. Recommend minimum 3 foot clearance from building.

Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. Ensure to maintain a copy of the most recent routine inspection report available upon request at all times.

Pest control service should be able to provide necessary feedback to operator and landlord on the services/areas treated and recommend corrections and structural improvements.
