Inspector Comments: The purpose of this follow-up was conducted per operators request.
On 3/31/21 this facility was closed during a routine inspection due to an imminent health hazard.
Facility was observed with an active rodent and roach infestation.

On this date person in charge stated facility had been cleaned and sanitized.
He provided pest control service reports where the technician noted base boards were sprayed for roaches.
Two mice were trapped on glue boards located in the ceiling. Facility added more traps inside of facility.

Further action:
Facility must be free of vermin and vermin evidence.
A one week reinspection will be conducted to verify compliance, failure to comply may result in a closure or billable inspection.

On this date all affected areas were observed clean. No evidence of rodents or roaches observed.

The health permit for this facility has been reinstated, this facility may now operate.

Description: The health permit to operate is hereby reinstated and facility may open.

Overall Inspection Comments

On this date after person in charge had a supervisory review at the EHS Rancho office. He stated his facility had been cleaned and sanitized. He requested a reinspection for this facility.
