Inspector Comments: The purpose of this visit was to conduct a complaint investigation.

Reference - HSC

Nature of Complaint: Complaint stated a roach ran across my table as the complainant was eating lunch.

Observations/Findings: I spoke to Chef, Ricky Moon, who heard of this complaint. The chef stated found a water bug at the dining area. The chef stated professional pest control service is performed every two (2) weeks. The chef provided a recent service invoice (08/16/2022).

Observed several live lymph german cockroaches under the electric portable heating oven across the cold holding sushi case.

Observed three (3) adult german cockroaches under the small reach-in refrigeration unit at the north east corner of the rear kitchen.

Observed one (1) merely dead adult german cockroach on the floor under the dishwasher.

Observed fifteen (15) dead adult german cockroaches on the floor in the storage area.

Observed several dead adult german cockroaches on the floor under and behind the unused upright single door reach-in refrigeration unit next to the ice machine in the rear kitchen.

Observed five (5) dead adult german cockroaches on the floor at the corner by the walk-in refrigerator door in the walk-in refrigerator.

Observed one (1) dead adult german cockroach on the floor under the soda machine at the server station.

Observed one (1) dead adult german cockroach on the floor at the northwest corner of men/women restroom area.

Observed many gaps at the bottom of the rear kitchen walls and damaged base cove in the kitchen area.

Results: The Health Permit was temporarily suspended this date due to the cockroach infestation in this food facility. Refer a routine inspection report for additional information.

Description: A complaint report has been received by Environmental Health.

Inspector Comments: Observed several live and numerous dead german nymph and adult cockroaches throughout the kitchen area and approximately thirty (30) mouse droppings under the ice machine and small reach-in refrigeration unit across the sushi cold holding case in the kitchen facility.

Not In Compliance

Violation Reference - HSC - 114259.1, 114259.4, 11425

Eliminate all vermin and evidence of vermin from this facility including but not limited to cockroaches and mouse droppings.

The Health Permit was temporarily suspended this date due to the cockroach infestation in this food facility.

The facility closure sign was posted on the front window.

A reinspection is required prior to reopen this food facility.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Observed several live nymph and adult german cockroaches and numerous dead german cockroaches in the kitchen facility.

 This facility must remain closed for business until a re-inspection is conducted and the health permit to operate this facility is reinstated by a representative of this agency.

Violation Description: If an imminent health hazard is found, an enforcement officer may temporarily suspend the permit and order the food facility immediately closed. (114409, 114405)
