5. HANDS CLEAN AND PROPERLY WASHED; GLOVES USED PROPERLY

POINTS 2	Compliance date not specified	Inspector Comments: Observed an employee remove used gloves and obtain new gloves without first washing their hands. Employee washed their hands after the inspector requested for them to do so. Ensure all employees wash their hands after gloves are removed and before handling food or donning a new pair of gloves.
	Not In Compliance Violation Reference -	

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))
