On this date a follow up inspection was conducted to verify compliance with a critical violation observed at the time of the last routine inspection.

Indicated on the last report facility was observed to have an rodent infestation.

A thorough inspection of the facility was conducted to verify vermin issue has been abated. Inspector observed no signs of current infestation. Pest control reports were reviewed at this time, no activity noted. Highly recommend to continue with receiving pest control service.

No further action regarding this violation is warranted at this time.

**Violation Description:** Reinspection conducted at this time to determine compliance from prior inspection.
