POINTS 4	Compliance date not specified Complied on 10/13/2021 Violation Reference -	Inspector Comments: Observed an employee handle money at the cash register and proceeded to serve food for the next customer with no hand wash step in between. Employees are required to wash hands immediately before engaging in food preparation and/or after engaging in other activities that contaminate the hands prior to food handling. Corrected on site.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

POINTS 2	Compliance date not specified Not In Compliance Violation Reference -	Inspector Comments: 1) Observed an employee rinse a blender in the hand wash sink adjacent to cash register. Discontinue this practice. Ensure hand wash sinks are only used for properly washing hands. 2) Observed a lid to a blender to be placed in the hand wash sink adjacent to cash register. Ensure the hand washing facility remains unobstructed at all times as to promote proper hand washing. Corrected on site.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

7. PROPER HOT AND COLD HOLDING TEMPERATURES

POINTS 2	Compliance date not specified Complied on 10/13/2021 Violation Reference - HSC - 113996, 113998, 114037	Inspector Comments: Observed a small container of cooked boba to be sitting out in room temperature on the prep table adjacent to blenders in the front area. Per manager the boba was placed there an hour prior to inspection. Ensure that potentially hazardous foods (PHFs) are held at or below 41F or at or above 135F. When using time as control only, the following conditions must be met: (1)The food shall be marked or otherwise identified to indicate the time that is four hours past the point in time when the food is removed from temperature control. (2) The food shall be cooked and served, served if ready-to-eat, or discarded within four hours from the point in time when the food is removed from temperature control. (3) The food in unmarked containers or packages or marked to exceed a four-hour limit shall be discarded. (4) Written procedures shall be maintained in the food facility and made available to the enforcement agency upon request. Corrected on site. Per employee the food items on the hot holding table were placed there approximately less than 10 minutes prior to inspection. Employee turned the timer on for all foods. Corrected on site. The manager placed the container of boba in ice.

Note: no ice was observed to be contaminated at the time of inspection. Ensure all food contact surfaces are maintained in a clean and sanitary condition. NOTE: A follow up inspection will be conducted in the future to observe compliance. Failure to comply may result in billable follow up inspections.

POINTS 1	Compliance date not specified Complied on 10/13/2021 Violation Reference - HSC - 114074, 114081, 114119	Inspector Comments: 1) Observed rice scoop was stored in standing room temperature water in a container by the rice cooker in the kitchen. Discontinue this practice and store the rice scoop in water that is at or below 41F degrees, or at or above 135F degrees. Corrected on site. 2) Observed one (1) pressurized tank stored near the hot holding table to not be secured to a rigid structure. Ensure that pressurized tanks are secured to a rigid structure at all times.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

Provide missing food handler card form within 14 days to avoid a future charged follow-up inspection. Note: Food handler cards MUST be issued by San Bernardino County to be valid. A food handler card form was provided.

Violation Description: This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code [Schedule of Fees](#). Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.

For a B grade (score of 80 to 89) A re-score inspection may be requested by a food facility who receives a "B" grade after the completion of an official routine inspection. This request is optional on the part of the facility which may wish to try to improve their score or letter grade. The Health Official will complete the re-score inspection within ten (10) County business days of the food facility submitting a request for a re-score inspection. The inspection rate is \$245.00 per hour. A minimum of \$122.50 will be charged for the first 30 minutes of inspection time. A Letter Grade Card shall remain valid until the Health Official completes the next routine inspection or re-score inspection of the food facility. A re-score inspection is a new, unscheduled, complete routine inspection that a) may be required by County Ordinance; or b) may be requested by the food facility.
