Not In Compliance	This facility was closed for business at the time of this inspection.
Reference - HSC	On 10/12/2021, the health permit for this facility was suspended due to a cockroach infestation. On this date, after a thorough inspection of the entire facility, observed no evidence of vermin-including cockroaches.
	The owner / operator produced recent professional exterminator receipts showing pest control service at this facility within the last twenty four (24) hours. This food facility was observed to be in a clean and sanitary condition at that time. The health permit for this facility was reinstated on this date. The notice of closure sign was removed and posted the letter grade on this date. Continue to maintain this facility in a clean and sanitary condition and free from vermin including but not limited to cockroaches.

Description: The health permit to operate is hereby reinstated and facility may open.

Not In Compliance	On 10/12/2021, observed several live German cockroaches in this facility including the kitchen, storage area, and restroom. On this date, after thorough inspection of this facility, observed no evidence of current or past evidence of vermin including but not limited to cockroaches. Observed the manager seals the holes and gaps in the ceilings and walls in the kitchen. The manager stated the professional pest control company visited yesterday and treated the facility.
Reference - HSC	Maintain this kitchen free from vermin including but not limited to cockroaches at all times. A "Notice of closure" sign removed and the letter grade was posted on this date.
