



7. PROPER HOT AND COLD HOLDING TEMPERATURES

POINTS 2	Compliance date not specified Complied on 10/1/2015 Violation Reference - HSC - 113996, 113998, 114037	Inspector Comments: Observed wedge tomatoes in dressing cold storage unit at 46-47 F. Employee stated the tomatoes had been sliced approximately three and a half hours prior to inspection and placed in the cold storage unit. Ensure potentially hazardous foods for cold holding are maintained at 41 F or below. If slicing tomatoes at room temperature they must be cooled to 41 F or below within 4 hours. Items are not meant to be cooled in cold storage unit. Recommend using an alternative cooling method and placing tomatoes in storage unit once they have been cooled to 41 F or below. Corrected on site. Employee put tomatoes in ice bath to cool to 41 F rapidly.

45. FLOORS, WALLS AND CEILINGS: BUILT, MAINTAINED, AND CLEAN

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114143 (d), 114266	Inspector Comments: Observed loose base coving tiles and a small hole in the wall near the back door and damaged base coving tiles and damaged wall paneling below the 3-compartment sink. Employee stated they have contacted a contractor to come out and repair the damaged floor and walls. Repair/replace damaged tiling and walls and maintain all floors, walls, and ceilings in good repair to prevent attraction/harborage of vermin.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
