Inspector Comments: Observed the facility to not have a health permit. The facility has gone through a change of ownership. Observed the facility to be called "Pho & Grill 18". The operator stated the facility has been operating under a new owner since April of 2018. Observed the following conditions not met by the operator that were set forth on the transfer of ownership:

- Observed 4 dining table with chairs in the waiting area.
- Observed no mop sink in the facility.

Immediately remove the dining tables and chairs from the facility since there is no access to the restrooms. Provide a mop sink. Obtain a health permit in order to operate. A follow-up will be conducted within a week to verify compliance. The facility is hereby closed and may not operate until it has received approval from environmental health services. If you have any questions please contact environmental health department at (800) 442-2283. Note if any major remodel is to be conducted please contact plan check at (800) 442-2283 prior to construction.

Violation Description: A food facility shall not be open for business without a valid permit. A permit shall be valid only for the specified permittee, location, and type of food sales or distribution activity. No food facility shall conduct activities that are inconsistent with the permit(s) issued by the enforcement agency. (114067(b) & (c), 114381 (a), 114381.2, 114387)

1. Observed the following sinks at the facility:

- A 3-compartment sink.
- A preparation sink.
- A hand wash sink.
- One (1) handwash sink in the restroom. Note a second restroom was observed in the facility but did not have a handwash sink.

2. Hot water: 120 degrees Fahrenheit measured from 3-compartment sink.
