NATURE OF COMPLAINT:

The complainant alleged that the facility turned the "B" grade card around from the street view.

OBSERVATION:

Observed the "B" grade card posted at the facility window to be turned around, with the "B" letter grade not facing the public street view, but inside the facility. Per person-in-charge, the facility was cleaning the windows and forgot to repost the grade card.

OUTCOME:

The "B" grade card was reposted onto the facility window right of the facility door entry, with the letter grade facing the public street view. Facility was informed the following:

DO NOT REMOVE, RELOCATE OR MOVE THE "B" GRADE CARD.

Failure to comply will result in a billable follow up inspection at an hourly rate of \$245.

No further action required. The complaint will be closed.
