A reinspection was conducted on this date per operator's request.

Facility was closed during most recent routine inspection due to cockroach infestation. Facility operator/owner has stated that the affected areas are cleaned and sanitized, and the facility is and free of vermin.

During this reinspection, no live vermin infestation was observed. Critical violation regarding vermin infestation has been corrected at the time of this inspection. The health permit to operate is hereby reinstated and facility may re-open.

A re-reinspection will be conducted within a week of this inspection to determine compliance. Any signs/evidence of past/current live vermin infestation will result in facility clsoure.

Observed old grease buildup on pipings behind cooking equipment at the front cook's line.

Observed grease buildup on base coving and floor under storage racks in rear storage area

Observed grease residue on walls under three compartment ware-washing sink, food prep sink, and hand washing sinks in the kitchen.

Observed old grease buildup under refrigeration drawers at the front cook's line

Observed old grease buildup under fryers at the front cook's line

Observed trash, stagnant water, and residue in cabinet under fountain soda dispenser at the time of this inspection.

Clean and sanitize all of the above mentioned areas and equipments so as to be in a clean and sanitary

Observed line fridge by the front cook's line has not been repaired (built-in thermometer reading 62F degrees) at the time of this inspection. Do not use this line fridge until it is repaired, and rechekced by San Bernardino County EHS.

Description: Reinspection conducted at this time to determine compliance from prior inspection.

A grade "B" placard was posted on facility's front window. Do not remove, hide, and/or tamper placard.
