Inspector Comments: Observed employee with gloved hands pick up an item (pen) that dropped to the floor near hand sink station. Observed same employee without washing hands and replacing gloves switched to taking food temperatures at food prep station. Ensure that every time tasks are changed or anytime potential cross contamination may occur, that gloves are changed and hands are washed properly.

Corrected on site.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

Inspector Comments: Observed cold foods held at 51F-53F in standing cold-holding unit behind front counter. Observed cheese cake and milk holding at 51-53F. Ensure all cold food items are held at 41F or below at all times.

NOTE: Corrected on site: Staff VC&D impacted food items.

NOTE: Observed unit's hanging thermometer reading at 50-51F.

NOTE: Food temperatures confirmed by Carl's Jr and Inspector's probe thermometers.

NOTE: Repair cold case to accurately hold temperatures at 41 F or less at all times.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Violation Description: When time only, rather than time and temperature is used as a public health control, records and documentation must be maintained. Food must be marked or otherwise identified as to what time the food was removed from temperature control. (114000) Food items shall not exceed the time marked. (114000)
