Overall Inspection Comments

"A" grade posted

Facility currently does not have full power. Per manager, electricity was discovered to be partially out when employees arrived at 6 am. Facility as light, however lights are flickering and refrigeration unit currently have no power. Inspector measured temperatures of foods inside customer display case and frozen foods were measured at around 20F and refrigerated items were measured at 41F and below. Foods in walk-in refrigerator measured at 35F and below and freezer measured 2-3F.

Per manager, he has called electric company and a technician is scheduled to come today. Manager also stated if technician is not here within the hour he will go buy dry ice to maintain foods in customer display cases and walk-in refrigerators below 41F.

Observed several cases of candy stored on the ground in aisle. Per manager, candies are currently being stocked onto shelves since store is re-arranging candy items after the Easter holiday.
