Discussed nature of complaint with operator who is not aware of complaint.

Upon inspecting food stored in walk-in-freezer, hot dogs were observed stored open with ice build-up on food. Operator was advised to store all food covered/sealed.

All other food stored in walk-in-cooler observed with no ice build-up; not frostbitten. Food stored in reach-in-freezer located at cooks line observed with no ice build-up.

Dining area, kitchen and toilet facilities observed clean at time of complaint inspection.

Complaint closed.
