Facility maintains monthly pest control service with Terminix. The service has now been increased to weekly until no more roaches are observed. Gave operator 2 weeks to get rid of the roaches.

(113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)
