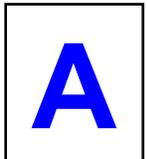

Inspector Comments: Taco's, taquito's, tamales were observed at 110°F, below hot hold temperature of 135°F.
 Food preparation table was observed with salsa, guacamole, at 50 - 56°F.
 Cold foods may require a deeper pan. Continue to trouble shoot for corrective action to maintain perishable foods at or below 41°F in preparation table.
 Hot foods were reduced in volume to maintain required temperatures.
 Additional perishable products were placed into hot hold unit until needed to restock display case.
 Tamale warmer was heated on stove.
 Potentially hazardous foods shall be held at or below 41F or at or above 135F.
 Discontinue to overfill food containers. Items above fill line are not holding at required temperatures.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Inspector Comments: Wet pans were observed stacked together.
 Allow wet pans enough time to air dry prior to stacking together for storage.

Violation Description: All food contact surfaces of utensils and equipment shall be clean and sanitized. (113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101 (b-d), 114105, 114109, 114111, 114113, 114115 (a, b, d), 114117, 114125(b), 114135, 114141)

38. ADEQUATE VENTILATION AND LIGHTING; DESIGNATED AREA

Inspector Comments: Observed several lights missing light covers. One area was above three compartments sink. The other area was dry food storage area.
 Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields.

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)

39. THERMOMETERS PROVIDED AND ACCURATE

Inspector Comments: Provide a temperature measuring device with a suitable probe designed to measure the temperature of thin masses of food is not provided and readily accessible to measure thin foods such as meat patties and fish fillets.

A readily visible thermometer was placed in the salsa refrigeration unit.

Violation Description: An accurate easily readable metal probe thermometer suitable for measuring temperature of food shall be available to the food handler. A thermometer +/- 2 F shall be provided for each hot and cold holding unit of potentially hazardous foods and high temperature warewashing machines. (114157, 114159)
