Ensure proper hand washing is being conducted with water temperature of at least 100 degrees F. Corrected on site: All employees were educated on correct hand washing procedure and all required to re-wash hand correctly prior to returning to work.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

All sinks measured maximum temperatures of approximately 72-75 degrees F. Ensure all sinks are able to provide hot and cold water. All preparation and food service has been ceased until all sinks are able to produce appropriate water temperatures. Corrected on site: Manager stated pilot light on water heater went out and was able to re-ignite water heater. Water temperatures at all sinks were measured at appropriate ranges.

33. NONFOOD-CONTACT SURFACES CLEAN

POINTS 1. Compliance date not specified. Not In Compliance. Violation Reference - HSC - 114115 (c). Inspector Comments: 1) Observed residue buildup on self service soda dispenser in dining area. Note: No residue buildup observed on soda nozzle or any food contact surfaces. 2) Observed grease and dust buildup on ventilation covers inside hood above frying station. 3) Observed dust accumulation on monitors hanging around kitchen area and drive through area. Maintain all non food contact surfaces clean at all times.

Violation Description: All nonfood contact surfaces of utensils and equipment shall be clean. (114115 (c))

45. FLOORS, WALLS AND CEILINGS: BUILT, MAINTAINED, AND CLEAN

POINTS 1. Compliance date not specified. Not In Compliance. Violation Reference - HSC - 114143 (d), 114266. Inspector Comments: 1) Observed grease and food debris buildup on floors throughout facility. Most notably under cooking equipment. 2) Observed dust accumulation on ventilation covers on ceiling near walk in cold holding unit. Ensure all floors, walls, and ceilings are maintained clean at all times.

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

IMPORTANT: Risk Based Inspection Frequency

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code Schedule of Fees. Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
