**Inspector Comments:** A first charged re-inspection was conducted at facility regarding 2 food worker card that has not been submitted to Division of Environmental Health Services (DEHS), within fourteen days of last routine inspection, 2-2-15.

Upon inspection, manager indicated one of the two employees no longer works at the facility and the second employee has obtained his food worker card. Food worker cards have been cleared, per inspector.

Note: Manager had attempted to fax form to main office twice and fax report indicated a "No Answer" result both times.

**Violation Description:** During your last routine inspection, it was noted that your facility was in violation of the food worker certification requirement for San Bernardino County. Since the inspection, food worker certification compliance has not been verified by Environmental Health staff. A billable reinspection has been conducted on this date to verify compliance.
