POINTS 4	Compliance date not specified Complied on 4/29/2021 Violation Reference -	Inspector Comments: Observed a food worker using gloves to handle raw meat, wipe their gloved hands on their apron, and begin to handle ready to eat foods without washing their hands and donning new gloves. Ensure all employees wash hands at the following times: before beginning work; before handling food/equipment/utensils; prior to donning gloves; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready-to-eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Corrected on site. Food worker instructed to wash their hands and don a new pair of gloves.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

7. PROPER HOT AND COLD HOLDING TEMPERATURES **MAJOR**

POINTS 4	Compliance date not specified Not In Compliance Violation Reference - HSC - 113996, 113998, 114037	Inspector Comments: Observed one (1) container of raw shelled eggs measuring between 73.6F and 76.4F stored on top of the microwave near the service window. Upon questioning, the manager stated that the eggs were removed from the walk in refrigerator and placed on the microwave approximately two (2) hours prior to inspection. Ensure that potentially hazardous foods (PHFs) are stored at or below 41F or at or above 135F. The food worker placed the eggs in the cold holding unit to cool the eggs to 41F or below.

Food workers were educated on this date to cook chicken to an internal temperature of at least 165F for fifteen (15) seconds.

Ensure that paper towels and handwash soap are available in dispensers at all handwash sinks at all times.

Corrected on site. The food worker placed paper towels in the dispenser at the handwash sink.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Ensure that food or ingredients removed from original packages are identified with the common name of the food, if not easily identifiable.

2. Observed frozen beef stored directly on the floor of the walk in freezer.

Discontinue this practice. Ensure that food stored at least six (6") inches above the floor on approved shelving in an approved location to prevent possible contamination.

Violation Description: Food shall be stored in approved containers and labeled as to contents. Food shall be stored at least 6" above the floor on approved shelving in an approved location to prevent possible contamination. (114047, 114049, 114051, 114053, 114055, 114067(h), 14069 (b))

- The three (3) doors of the reach in cold holding unit underneath the cold holding table
- The two (2) doors of the reach in cold holding unit near the beverage machine.

Clean the back of the handles and maintain nonfood-contact surfaces clean.

Violation Description: All nonfood contact surfaces of utensils and equipment shall be clean. (114115 (c))

Observed several utensils stored in a drawer containing residue and debris. Ensure that equipment and utensils are stored in a safe and sanitary manner to prevent contamination. 2. Observed one (1) styrofoam bowl used as a scoop in a bulk container stored in the dry storage area. Discontinue this practice. Ensure use of approved scoops with handles and that the handles are stored upright and out of food.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

Observed no toilet paper available in the dispenser in the employee restroom. 2. Observed toilet paper stored on top of the dispenser in one (1) stall in the women's restroom. Ensure that toilet paper is provided inside a wall mounted dispenser at all times.

Violation Description: Toilet facilities shall be maintained clean, sanitary and in good repair for use by employees and patrons. Toilet rooms shall be separated by a well-fitting, self-closing door. Toilet tissue shall be provided in a permanently installed dispenser at each toilet. Location of toilet facilities used by patrons shall not be located to pass through food preparation, food storage, or utensil washing areas. (114250, 114250.1, 114276)

Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
- A permit suspension (closure) on your last graded inspection.
