**Inspector Comments:** A complaint was placed with the San Bernardino County Division of Environmental Health on November 8, 2015. The complainant stated they ate at the restaurant on Nov 7th. Complainant stated that the meal consumed at the restaurant was the first and only meal consumed on the day the illness set in. Complainant stated their meal consisted of broccoli and cheese soup, green salad with blue cheese dressing, chicken from taco bar, Spaghetti with meatball sauce, chicken wings, melon, and soft serve ice cream. Complainant stated approximately 3 and a half hours after consuming this meal they proceeded to vomit every 30 minutes for the next 9 hours.

1. Has the facility recently received similar foodborne illness complaints? If so, were the complaints about the suspect food or another type of food? No
2. Have any of the food handlers recently called in sick? Have any of the food handlers exhibited the symptoms of a foodborne illness while at work? No
3. Has the facility recently experienced any food processing failure, such as:
  - a. Refrigeration problems- No
  - b. Water outage- No
  - c. Electrical power outage- No
  - d. Hot water heater failure-No
  - e. Sewage/wastewater overflow in the food preparation or storage areas - No

At the time of the complaint investigation all of the items identified in the complaint were holding at appropriate temperatures. Cook was able to demonstrate knowledge on cooking temperatures. Employees were also able to demonstrate knowledge on reheating, cold holding and hot holding temperature requirements. Sanitizer concentration at the dish washing station and at the sanitizer buckets around the facility met the minimum concentration. At the time of the complaint investigation the routine inspection was also conducted. See PR0005783 for the routine health inspection report.
