Inspector Comments: It has been observed that the following facility has tampered with or removed the "B" grade sign that was posted from the routine inspection conducted 2-26-19. The manager was notified verbally, sign was replaced. Manager was reminded as indicated on the official inspection report "Do NOT remove or relocate grade card. Non-compliance will result in a charged follow up inspection at an hourly rate of \$245."

Ensure that grade card is NOT removed or located.

Violation Description: Handwashing signs shall be posted in each toilet room, directing attention to the need to thoroughly wash hands after using the restroom (113953.5) (b) No smoking signs shall be posted in food preparation, food storage, warewashing, and utensil storage areas (113978). (c) Consumers shall be notified that clean tableware is to be used when they return to self-service areas such as salad bars and buffets. (d) Any food facility constructed before January 1, 2004 without public toilet facilities, shall prominently post a sign within the food facility in a public area stating that toilet facilities are not provided (113725.1, 114381 (e)). A sign shall be posted stating that a copy of the most recent routine inspection report is available upon request. (113725.1) Permit shall be posted in conspicuous location. (114381(e)) Letter Grade Placecard shall be properly posted. SBCC 33.1406
