Inspector Comments:

Maintain potentially hazardous foods for cold holding at 41F or below.

The following was observed in ice bath near flat grill:
1. raw hamburger patties at 47F

All other food in ice bath were observed with temperatures in compliance.
Ice bath was refilled with ice. Ensure ice is high enough to facilitate full cold air circulation.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Inspector Comments:

Ensure there are no gaps in between hood filters so that exhaust hood can properly vent.

Observed dented hood filters creating gaps between filters.

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. (114149.2, 114149.3, 114252, 114252.1)

40. WIPING CLOTHS: PROPERLY USED AND STORED

Inspector Comments:

Store wet wiping cloths in an approved sanitizer solution between 100 and 200ppm when using chlorine/bleach sanitizer.

Observed two sanitizer buckets at 50ppm.
Facility is using prepackaged sanitizer packets. Recommend to mark buckets for the appropriate amount of water to ensure consistent concentration of sanitizer.

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

Violation Description: This facility is currently in violation with the food handler certification requirement for San Bernardino County, which states all food handlers must obtain a valid food handler certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food handler certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
