

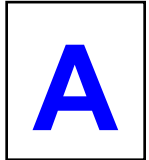

22. SEWAGE AND WASTEWATER PROPERLY DISPOSED

POINTS <div style="border: 1px solid black; padding: 5px; display: inline-block; font-size: 24pt; font-weight: bold;">2</div>	Compliance date not specified Not In Compliance Violation Reference - HSC - 114197	Inspector Comments: Observed the following: - Water rising from the janitorial sink when the toilet was flushed while water was running from the janitorial faucet. After further inspection, no overflow was observed when all the water faucets were turned on and the toilet was flushed. Employee stated the toilet facilities were closed since February for employee and customer use and that the toilet facilities of the neighboring restaurant were used. The neighboring restaurant is accessible from inside the facility. - Leak of water coming from inside the water tank of the toilet. Employee stated that water also leaks from the base of the toilet. Repair/ replace toilet and plumbing and maintain in good repair. Employee stated the plumber was scheduled to come to facility between 5:00 p.m. and 7:00 p.m. on this date. A reinspection will be conducted on next day, 6/1/2022, to determine compliance. Non-compliance will result in a billable follow-up re-inspection at an hourly rate of \$245 with a minimum charge of \$122.50.

26. APPROVED THAWING METHODS USED, FROZEN FOOD

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114018, 114020, 114020.1	<p>Inspector Comments: Observed three (3) gallons of soft serve mix under running water and without being submerged in the prep sink. Employee stated it was in the process of thawing for 30 minutes.</p> <p>Discontinue this practice. Ensure foods are thawed via the following approved methods:</p> <ul style="list-style-type: none"> -under refrigeration -completely submerged in cold (no higher than 70F), running water for less than 2 hours -in a microwave -during the cooking process.

Violation Description: Food shall be thawed under refrigeration; completely submerged under cold running water (less than 70F) of sufficient velocity to flush loose particles for less than 2 hours; in microwave oven; or during the cooking process. (114018, 114020, 114020.1)

40. WIPING CLOTHS: PROPERLY USED AND STORED

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114135, 114185.1	<p>Inspector Comments: Observed wet wiping towels stored in less than 100 ppm quaternary ammonium sanitizer solution.</p> <p>Maintain quaternary ammonium sanitizer solution above 200 ppm.</p> <p>Corrected on site. Employee replenished sanitizer.</p> <p>Note: Wiping towels not observed in use.</p>

Violation Description: Wiping cloths used to wipe service counters, scales or other surfaces that may come into contact with food shall be used only once unless kept in clean water with sanitizer. (114135, 114185.1, 114185.3 (d-e)) Sponges shall not be used in contact with cleaned and sanitized or in-use food contact surfaces. (114135)

41. PLUMBING; PROPER BACKFLOW DEVICES

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114171, 114189.1	<p>Inspector Comments: Observed missing handle on faucet of 3-compartment sink. Faucet could not be turned on to provide water. Water was still accessible from faucet sprayer and hoses that provide sanitizer and detergent.</p> <p>Repair/ replace handle on faucet and maintain in good repair.</p>

Violation Description: The potable water supply shall be protected with a backflow or back siphonage protection device, as required by applicable plumbing codes. (114192) All plumbing and plumbing fixtures shall be installed in compliance with local plumbing ordinances, shall be maintained so as to prevent any contamination, and shall be kept clean, fully operative, and in good repair. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. (114171, 114189.1, 114190, 114193, 114193.1, 114199, 114201, 114269)

IMPORTANT: Risk Based Inspection Frequency

Food facilities that pose a higher risk level for causing foodborne illness will be subject to an additional inspection, to be billed at the hourly rate as provided in the San Bernardino County Code [Schedule of Fees](#). Facilities that received one or more of the following will be elevated to a high risk tier:

- A score letter of "C" or lower on one of the last two graded inspections,
- A score letter of "B" on two of the last three graded inspections,
- Repeated "four (4) point violation Risk Factor" (critical violation codes 1-23) on the last two inspections, or
- Four (4) or more critical violations (codes 1-23) noted during an inspection, or
