Our records indicate that your San Bernardino County health permit to operate this food facility has outstanding balance. Once suspended you may not operate this food facility under this health permit.

After speaking of the owner over the phone, the owner of this food facility is requested to have a payment plan. Upon speaking with supervisor and fiscal department, Department of Environmental Health Services (DEHS) will work with the owner of this food facility and set a payment plan. The owner will be contacted by fiscal department today.

A reinspection will be conducted on or after 01/15/2020 to determine compliance. Non-compliance will result in the health permit suspension and the facility closure.

Description: Obtain a valid health permit within 3 days or as specified to avoid facility closure and/or other possible legal action.
