

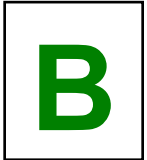

Inspector Comments: Observed slime and black-like mold substance accumulation up on the ice deflector and perimeter in the ice machine. Observed condensation from machine drop directly onto ice inside machine. Active contamination was observed.

Immediately discontinue use of ice and clean and sanitize machine. Maintain food in good condition and free of adulteration and/or spoilage at all times.

Corrected on site. The person in charge placed a "DO NOT USE" sign on the ice machine. At the time of inspection, the employee discarded of the ice, clean and sanitized the ice machine. (See VC&D).

Violation Description: All food shall be manufactured, produces, prepared, compounded, packed, transported, kept for sale, and served so as to be pure and free from adulteration and spoilage. Any food is adulterated if it bears or contains any poisonous or deleterious substance that may render it impure or injurious to health. Inspector Comments: Observed the hand wash sink located next to the preparation sink to be blocked by a cart.

Ensure hand washing facilities remains unobstructed at all times so as to promote properly wash hands.

Corrected on site. The employee relocated the cart to have access to the hand washing sink.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Inspector Comments: (1) Observed several old rodent droppings on the floor inside the cabinets located underneath the soda machine. After a thorough search of the facility, observed no signs of an active infestation. NOTE: No food or food contact surfaces were observed to be contaminated.

(2) Observed one (1) dead adult cockroach in the facility, near the storage rack containing sugar located in the dry storage area. After a thorough search of the facility, observed no signs of an active infestation.

(3) Observed a sticky trap with several dead adult cockroaches underneath a dinning table located in the customer dinning area.

(4) Observed several ants on the floor in the storage room located underneath the storage rack storing containers of sugar, floor, and rice, although none observed on food.

Clean and sanitize all affected areas and maintain the facility free from vermin. Remove and eliminate any evidence of rodents, cockroaches, and ants. A re-inspection will be conducted on a later date to verify compliance and or progress towards rodent/insect elimination.

Violation Description: Food facility shall be kept free of vermin: rodents (rats, mice), cockroaches, flies. (114259.1, 114259.4, 114259.5) Live animals are not allowed in a food facility unless, food employees with service animals may handle or care for their service animal if they wash their hands as required or persons who are licensed pursuant to Chapter 11.5 of Division 3 of the Business and Professions Code. (114259.4, 114259.5)

Upon questioning, the person in charge stated that the filters were taken out, due to cleaning inside the ventilation hood. Provide proper fitting filters in the ventilation hood to allow for proper grease ventilation at all times. A re-inspection will be conducted on a later date to verify compliance of the grease filters on the ventilation hood.

Violation Description: Exhaust hoods shall be provided to remove toxic gases, heat, grease, vapors and smoke and be approved by the local building department. Canopy-type hoods shall extend 6" beyond all cooking equipment. All areas shall have sufficient ventilation to facilitate proper food storage. Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114149, 114149.1) Adequate lighting shall be provided in all areas to facilitate cleaning and inspection. Light fixtures in areas where open food is stored, served, prepared, and where utensils are washed shall be of shatterproof construction or protected with light shields. The employee returned the wet wiping towels to the sanitizer bucket.
