Inspector Comments: The purpose of this visit was to conduct a complaint investigation.

The management did not hear about this complaint.

Nature of Complaint: The store is selling expire/out dated food. The food is over a year old.

On this date, observed expired candies and cookies at the shelves in Isle 2. Observed no poor condition, contamination, or adulteration of food at that time of this inspection.

However, observed over hundred (100) severely and moderately dented cans stored at the shelves in Isle 2 and 3.

Ensure food intended for customer is in good condition, unadulterated and free of contamination. All dented cans were removed and discarded by the manager.

No further action warranted on this date. The case is closed.

Description: A complaint report has been received by Environmental Health.

**16C013 Food in good condition, safe and unadulterated**

Inspector Comments: Observed over hundred (100) dented (four severely dented) cans stored at the shelf in isle 2. This is the repeated violation from last inspection.

Not In Compliance

Violation Reference - HSC - 113967, 113976,

Removed dented cans immediately from the customer selves. Ensure food intended for customer is in good condition, unadulterated and free of contamination.

Corrected on site. The dented cans were removed and discarded by the manager.

Violation Description: All food shall be manufactured, produces, prepared, compounded, packed, transported, kept for sale, and served so as to be pure and free from adulteration and spoilage. Any food is adulterated if it bears or contains any poisonous or deleterious substance that may render it impure or injurious to health. (113967, 113976, 113980, 113988, 113990, 114035, 114254(c), 114254.3)
