

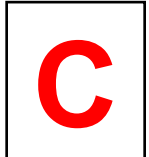

Inspector Comments:

The dishwasher/cook was observed washing dirty dishes at the dishwashing station, then entered the cooks station where he was observed cooking food and handling pans of food items.

All employees are to thoroughly wash their hands in between job duties with warm water and soap.

The manager was informed to have the dishwasher/cook wash his hands.

Violation Description: Employees are required to wash their hands: before beginning work; before handling food / equipment / utensils; as often as necessary, during food preparation, to remove soil and contamination; when switching from working with raw to ready to eat foods, after touching body parts; after using toilet room; or any time when contamination may occur. Gloves shall be worn if an employee has cuts, wounds, fake nails, nail polish, and/or rashes. Gloves are to be used for no more than one task. Employees are not to wrap or package leftover food using bare hands or unclean utensils. Hand sanitizers may be used after proper hand washing. Employees handling food must have fingernails that are trimmed, cleanable, and smooth. (113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f))

These items were removed from the buffet line and placed in the dessert refrigeration unit in the kitchen.

Maintain all cold foods 41 F or below.

Under cold running water</p> <p>The manager placed the package of beef in the walk-in refrigerator.</p>

Toilet rooms shall be vented to the outside air by a screened openable window, an air shaft, or a light-switch activated exhaust fan, consistent with local building codes. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable.
