**Inspector Comments:** A complaint inspection was conducted on this date in response to a complaint received by Environmental Health Services.

Nature of complaint:

The complainant alleged that there was sewage water back up inside of the kitchen and dining room area.

Findings:

- Manager was aware of the complaint
- Manager stated that the sewage back up started in the restroom and that a plumber has repaired the plumbing issue

Observed the following:

- Facility was open during the time of inspection
- Floors were in the process of being cleaned during the time of inspection
- Back area of the kitchen was observed to be clean and water from the three compartment sink, mop sink and the handwashing sink was turned on and water was able to properly drain
- Floor sink under the soft drink dispenser was observed to have debris
- Restroom was observed to have sewage back up on the floor

Manager was instructed to discontinue food preparation and clean and sanitize all affected areas.

Facility is closed as of further notice. Follow up is required.
