The health permit for this facility was suspended and the this facility was closed on 5/11/2018 due to a live cockroach infestation that was observed in the kitchen facility. On this date, after a thorough inspection of the entire kitchen, live activity was observed. One live adult cockroach was observed in the front kitchen on the floor by the soy sauce storage containers, one live nymph cockroach was observed on the floor underneath the three compartment sink, and one live nymph cockroach was observed on the floor by the door that separates the kitchen and dining room area. In addition, one dead cockroach was observed on the floor outside the walk-in cooler. Due to the live activity observed on this date, the health permit was not reinstated. The owner / operator produced professional exterminator receipts showing pest control service at this facility was conducted on 5/11/2018 and stated the professional exterminator will come out today and conduct more treatment.
