POINTS 4	Compliance date not specified Not In Compliance Violation Reference - HSC - 113996, 113998, 114037	Inspector Comments: Observed garlic-in-oil mixture at 72F on prep table and raw chicken at 56F at cold table at approximately 3:00 pm. Maintain potentially hazardous foods cold at 41F and below or hot at 135F and above. Operator able to cool chicken to 41F within 10 minutes. Garlic-in-oil discarded. See VC&D, #52.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

POINTS 1	Compliance date not specified Not In Compliance Violation Reference - HSC - 114074, 114081, 114119	Inspector Comments: Observed rice paddles stored in water measuring 61F. Per owner, paddles were stored in ice water earlier but ice melted. Maintain utensils in use with potentially hazardous foods cold at 41F and below or hot at 135F and above. Observed soiled dishes stored on refrigerator in a manner that obstructed access to foods in cold table portion. Store soiled dishes away from food, food prep surfaces, and utensils to avoid cross contamination. Observed box of single-use utensils stored on floor. Store utensils in a manner that protects from contamination.

Violation Description: All clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces. (114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. (114074 - 114075, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.5) Pressurized cylinders must be securely fastened to a rigid structure. (114172)

48. FOOD WORKER CERTIFICATION

POINTS 2	Compliance date not specified Not In Compliance Violation Reference - SBCC - 33.0410, 33.044	Inspector Comments: Observed 1 food worker card expired 1/26/15. Obtain valid San Bernardino County Food Worker Card within 14 days. Complete and fax form provided to Environmental Health Services by the date specified to avoid a billable reinspection (\$245 hourly, 1/2 hour minimum).

Violation Description: This facility is currently in violation with the food worker certification requirement for San Bernardino County, which states all food workers must obtain a valid food worker certificate within fourteen (14) days of employment (33.0410, 33.044). Failure to provide proof of food worker certification within fourteen (14) days will result in unannounced billable (at our current hourly rate) re-inspections to verify compliance.
