Cook stated that they were uncertain of length of time the potentially hazardous food (PHF) was placed on the counter. Maintain the temperature of all potentially hazardous foods at or below 41 F or at or above 135 F at all times. The above PHF was voluntarily condemned and destroyed by the person in charge. See VC&D.

Violation Description: Potentially hazardous foods shall be held at or below 41F or at or above 135F. (113996, 113998, 114037, 114343(a))

Allow full, unimpeded access to handwashing sinks at all times. 2. Observed handwashing sink next to three-compartment sink blocked by an insert containing a large chef knife in the sink and blocked by large trashcan. Discontinue this practice. Allow full, unimpeded access to handwashing sinks at all times. 3. Observed no hand towels at BOTH handwashing sinks in kitchen area. Provide hand towels to all handwashing sinks at all times for proper hand washing. Corrected on site. Operator provided hand towels to both handwashing sinks in kitchen area.

Violation Description: Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

8. TIME AS A PUBLIC HEALTH CONTROL; PROCEDURES & RECORDS

POINTS 2	Compliance date not specified Not In Compliance Violation Reference - HSC - 114000	Inspector Comments: Observed large container of cooked rice stored on shelving at room temperature. Cook stated that the rice is used for sushi dishes and is under time as a public health control. Container was missing time stamp. Ensure a time stamp is recorded at the time the PHF (rice) is removed from temperature control. NOTE: Cook stated the rice was removed from temperature at 11:00am and that any remaining rice will be disposed of at 3:00pm at the four (4) hour mark. The time this food item was inspected was 2:00pm.

Violation Description: When time only, rather than time and temperature, is used as a public health control; food must be marked or otherwise identified as to what time the food was removed from temperature control. (114000) Food items shall not exceed the time marked. (114000)

Inspector Comments: Observed salsa with diced tomatoes in reach-in cooler measured at 51 F. Cook stated the salsa was freshly prepared more than four (4) hours prior to inspection.

Rapidly cool all potentially hazardous foods from 135 F To 71 F within two (2) hours and from 70 F to 41 F within four (4) hours.

Corrected on site. The above PHF was voluntarily condemned and destroyed by the person in charge. See VC&D.

See text below for proper cooling methods.

Violation Description: All potentially hazardous food shall be RAPIDLY cooled from 135F to 70F, within 2 hours, and then from 70F to 41 F, within 4 hours. Cooling shall be by one or more of the following methods: in shallow containers; separating food into smaller portions; adding ice as an ingredient; using an ice bath; stirring frequently; using rapid cooling equipment; or, using containers that facilitate heat transfer. PHF is to be cooled within 4 hours to 41F if prepared from ingredients at ambient temperature. Deliveries of PHF is to be cooled to below 41F within 4 hours if received between 41F to 45F.

Inspector Comments: Observed ten (10) pounds of frozen shrimp thawing in standing water in two-compartment prep sink. Operator stated that the shrimp was placed in the standing water 20 minutes prior to inspection.

Discontinue this practice. Only use approved thawing methods outlined below.

NOTE: This frozen shrimp was defrosted using one of the following approved methods:

- 1) In the refrigeration unit.
- 2) In the microwave oven.
- 3) As part of the cooking the refrigeration unit.
- 4) Under cold running water.

Violation Description: Food shall be thawed under refrigeration; completely submerged under cold running water (less than 70F) of sufficient velocity to flush loose particles for less than 2 hours; in microwave oven; or during the cooking process. (114018, 114020, 114020.1)

Violation Description: Food facilities that prepare food shall be equipped with warewashing facilities. Testing equipment and materials shall be provided to measure the applicable sanitization method. (114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125) A thermometer must be readily available to monitor the temperature of the water at the warewashing sink. A warewashing sink used to wash wiping cloths, wash produce, or thaw food must be cleaned and sanitized before and after each use.

(114185.3 - 114185.4) Utensils and equipment shall be handled and stored so as to be protected from contamination. Any hose used for conveying potable water shall be of approved materials, labeled, properly stored, and used for no other purpose. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))
