The employee stated that dishes/equipment are washed, submerged in chlorine sanitizer (measuring in between 50ppm and 100ppm) for 20 seconds, rinsed with hot water, and then dried with a towel.</p> <p>Ensure all employees are able to demonstrate knowledge of and are properly trained in food safety.</p> <p>Note: The employee was educated at the time of inspection. Corrected onsite.</p>

All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable.
