Maintain hand wash sinks available with necessary supplies. Lack of required soap and paper towels in a wall mounted dispenser at hand wash sink in restroom.

**Violation Description:** Handwashing soap and towels or drying device shall be provided in dispensers; dispensers shall be maintained in good repair. (113953.2) Adequate facilities shall be provided for hand washing. (113953, 113953.1, 114067(f)). Handwashing sink is not separated from a warewashing sink by a 6 inch high metal splashguard or 24 inch separation. (113953) Handwashing sinks shall not be obstructed, inaccessible, used improperly or kept unclean. (113953.1)

Four taquitos steak and cheese 54°F, 16 buffalo style ranch flavor taquitos 52°F, 8 cheese and jalapenos taquitos. 6 chicken monterey cheese. Items were removed from preparation refrigerator to be discarded. Remove perishable foods from refrigeration unit until it operates at 41°F or less. One box states thawed foods are good for 7 days. No date on label. Diced tomatoes 1/2 pint in well 52°F. Pico de gallo 1 pint in well 54°F.  Maintain potentially hazardous foods at or below 41F or at or above 135F.

(114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided.
