Violation Description: The premises of each food facility shall be kept clean and free of litter and rubbish; all clean and soiled linen shall be properly stored; non-food items shall be stored and displayed separate from food and food-contact surfaces; the facility shall be kept vermin proof. (114067 (j), 114123, 114143 (a) & (b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282) Food preparation sinks, handwashing sinks and warewashing equipment shall not be used for the cleaning of maintenance tools, the holding of maintenance materials, or the disposal of liquid wastes. (114123) Open-air barbecue and/or outdoor wood burning oven must operate on the same premises, in conjunction with a permanent food facility and not in an area that may pose as a fire hazard. (114143(a) (b)) Janitorial sink or approved curbed cleaning facility (exemption for restricted food service facilities Section 114279 (b)) shall be provided. (114279(a)) First aid supplies must have a legible manufacturer's label and stored in a kit or container that is located to prevent contamination. (114256.4) Insect electrocution devices are not allowed in food or utensil handling areas. (114259.3)

Violation Description: The walls / ceilings shall have durable, smooth, nonabsorbent, and washable surfaces. All floor surfaces, other than the customer service areas, shall be approved, smooth, durable and made of nonabsorbent material that is easily cleanable. Approved base coving shall be provided in all areas, except customer service areas and where food is stored in original unopened containers. Food facilities shall be fully enclosed. All food facilities shall be kept clean and in good repair. (114143 (d), 114257, 114266, 114268, 114268.1, 114271, 114272) Cleaning must be an approved dustless method. (114268.1) Mats and duckboards, if used, must be removable and easily cleanable. (114272) Open-air barbecues or wood-burning ovens floor surfaces must extend a minimum of five feet and be impervious or easily cleanable. (114143(d))

The following stickers were placed during the inspection: one (1) handwash sticker in the employee restroom, one (1) proper cook temperature sticker placed at cook line, three (3) cold holding temperature stickers at several reach-in refrigerators, and one (1) hot holding sticker at cook line steam table.

General observations:

- * Hot water temperature as measured with a thermocouple probe thermometer: greater than 120 F at three compartment sink, handwash sinks and the janitorial mop sink.
- * Wiping cloth buckets tested for sanitizer concentration using chemical test strip and verified to be greater than 200 parts per million quaternary ammonia.
- * Mechanical chemical sanitizing (chlorine) dishwasher observed during a complete wash cycle. The rinse water at the end of the cycle was tested for chlorine concentration using a chemical test strip and was verified to be above 50 parts per million.
- * All refrigeration units verified to be holding at or below 41 F using an IR thermometer and a thermocouple probe thermometer on representative foods.
- * All hot holding units verified to be holding at or above 135 F via thermocouple probe thermometers.
- * All handwash sink dispensers were observed to be well stocked with soap and paper towels.
- * The staff displays good food knowledge and exhibited good food handling practices.
